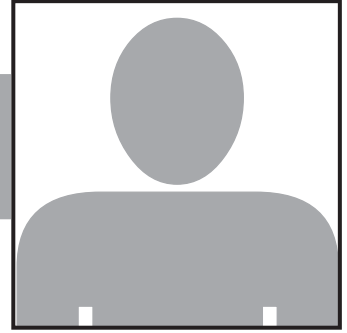

- (d) undertake at all times to maintain a minimum credit balance of N2,000.00 in my/our account with you.
- (e) authorize you to sell any securities held by you in my/our behalf if the debit balance on my/our account at any time exceeds 50% of the market value of the securities.
- (f) authorize you to debit my/our account with your annual ledger fee (currently N 1,000.00 p.a)
- (g) undertake not to hold you responsible for delays in the transmission of orders due to breakdown or failure of transmission or communication facilities or for any other causes beyond your reasonable control or anticipation.
